The signature below represents an agreement between the Artist/Model and Grady McWhiney Research Foundation (GMRF) dba Buffalo Gap Historic Village (BGHV) to participate in the 2006 Images in Time Artists' Photo Shoot (Event). This agreement represents a waiver for Model to allow all photographs taken in the course of the Event to be reproduced in likeness by the participating Artist(s). This agreement does not give anyone other than those Artists/Models at the Event the right to use the model's image or costumes for any other purpose whatsoever. Photographs from the Event may not be given or sold to any non-participating Artist/Model without permission from Buffalo Gap Historic Village, Grady McWhiney Research Foundation, and the participating Artists/Models.

I hereby release GMRF dba BGHV and the employees of GMRF and/or BGHV from any liability whatsoever, for any harm or injury that may be suffered by me, or from any loss or damage to my property, whether caused by employee, visitor, or any other source, during the course of my involvement with BGHV, as an artist and/or model.

I understand that my involvement with BGHV is of a strictly voluntary nature. I accept involvement with BGHV with full knowledge that GMRF, BGHV, or the employees of GMRF and/or BGHV do not accept responsibility or liability for any physical or mental injuries, or property damage caused to me, whether they be purposeful or accidental, regardless of the source, which may result from the participation in the Event. The purpose and intent of this release is to state in advance, that in the event of any injury or property damage sustained by me, that GMRF, BGHV, and the employees of GMRF and/or BGHV shall be held harmless by me.

Artist/Model/Guardian agrees that this registration form has been read and that this release is understood. It is agreed to bring no valuables to BGHV. Artist/Model is hereby notified that in the event of any form of behavior deemed disruptive or inappropriate, as determined by an Event representative, the individual(s) in question will be escorted from the premises. Such individual(s) will not be allowed to return to the Event and all monies paid toward the Event will be forfeited by the individual(s). If required, notification of the appropriate authority to assist in this dismissal will be activated. Participation in future Events will be reviewed before deposit/fee is accepted and/or admission is allowed for such individual(s).

This agreement may be cancelled by the Artist/Model/Guardian five (5) business days prior to the Event. Refund of deposit/fee will be returned in the form of check (for receipt of check or cash) or of credit card (for receipt of credit card) within ten (10) business days from the end date of the Event. Otherwise, the monies received will be forfeited.
